As the Hon. Bombay High Court vide order dated 06/10/2005 in Writ
Petition No (L) No.3246 of 2004 the Bombay Environmental Action Group V/s State of
Maharashtra directed the State Government to designate an Officer not below the rank of
District Magistrate to see that the orders of the Hon. High Court are implemented and to
entertain the complaints received regarding the destruction of mangroves. Accordingly,
the State Government Revenue Department designated the Divisional Commissioner,
Konkan Division to implement the orders of the Hon. High Court in respect of
preservation of mangroves and to prevent the destruction thereof.

According to para. 8 (vi) of the Hon. High Court order, the State
Government is directed to file a monthly report to the Hon. High Court about the action
taken on the complaints of destruction of mangroves received. The 170th report in this
regard has been submitted on 04/12/2019.

I am now submitting herewith 171th Monthly Report from 1st December,
2019 to 31st December, 2019. The same may please be brought to the notice of the Hon.
High Court, Mumbai.
